<u>Eligibility</u>: - MBBS with 01 year internship. Those applicants, who have completed two years of their internship before the last date of receiving of application, need not apply. Candidates who have completed their internship on or before last date for submission of application are eligible. He / She must have valid DMC registration at the time of joining.
