

PRE-CONTRACT-INTEGRITY PACT

This pre-bid pre-contract Agreement (herein after called the Integrity Pact is made on

BETWEEN

GIPMER, GOVT. OF NCT OF DELHI, represented by the HEAD OF INSTITUTE G B PANT HOSPITAL/ GIPMER, GNCTD hereinafter referred to as "THE PRINCIPAL" / "EMPLOYER"

AND

We authorized signatory of Siemens Healthcare Private Limited with office at Siemens Healthcare Pvt. Ltd., Unit no. 1 & 2 Skootr Business Centre, 2nd floor, Infinity Tower, DLF Cybercity Gurugram -1220002, Haryana hereinafter referred to as "The BIDDER/ CONTRACTOR."

Preamble

The Principal intends to award, under laid down organizational procedures, contract/s for procurement of 01 (one) CT Scanners 128 Slice for RADIOLOGY DEPARTMENT, GIPMER. The Principal values full compliance with all relevant laws and regulations, and the principles of economic use of resources, and of fairness and transparency in its relations with the Bidder/s and Contractor/s.

In order to achieve these goals, the principal will appoint an External Independent Monitor who will monitor the tender process and the execution of the contract for compliance with the principles mentioned above.

NOW, THEREFORE, the Buyer and the bidder agree enter into this pre-contract agreement, hereinafter referred to Integrity Pact to avoid all forms of corruption by following a system that is fair, transparent and free from any influence / prejudiced dealings prior to, during and subsequent to the currency of the contract to be entered into with a view to: -

Enabling the PRINCIPAL/EMPLOYER to obtain the desired said stores / equipment at a competitive price in conformity with the defined specifications by avoiding the high cost and the distortionary impact of corruption on public procurement, and

Enabling BIDDERs /CONTRACTORs to abstain from bribing or indulging in any corrupt practice in order to secure the contract by providing assurance to them that their competitors will also abstain from bribing and other corrupt practices and the PRINCIPAL/EMPLOYER will commit to prevent corruption, in any form, by its officials by following transparent procedures.

The parties hereto hereby agree to enter into this Integrity Pact and agree as follows: -

Commitments of the PRINCIPAL/EMPLOYER

The PRINCIPAL/EMPLOYER undertakes that no official of the Principal/Employer connected directly or indirectly with the contract, will demand, take a promise for or accept, directly or through intermediaries, any bribe, consideration, gift, reward, favour or any material or immaterial benefit or any other advantage from the BIDDER,/CONTRACTOR either for themselves or for any person, organization or third party related to the contract in exchange for an advantage in the bidding process, bid evaluation, contracting or implementation process related to the contract.

The PRINCIPAL/EMPLOYER will, during the pre-contract stage, treat all BIDDERs/CONTRACTORs alike, and will provide to all BIDDERs/ CONTRACTORs the same information and will not provide any such information to any particular BIDDER which could afford an advantage to that particular BIDDER in comparison to other BIDDER and could obtain an advantage in relation to the tender process or the contract execution.

All the officials of the PRINCIPAL/EMPLOYER will report to the HEAD OF INSTITUTE, GB PANT HOSPTIAL/ GIPMER, GNCTD any attempted or completed breaches of the above commitments as part of the bidders as well as any substantial, suspicion of such a breach.

Commitments of the BIDDER/ CONTRACTOR

The Bidder/ Contractor commit himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the tender process and during the post contract stage.

- i) The Bidder/contractor will not enter with other Bidder/contractor into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.
- ii) The Bidder/ contractor will not commit any offence under the Indian Penal Code, 1860 / Prevention of Corruption Act, 1988 further the Bidder/ contractor will not use improperly, for purposes of competition or personal gain, or pass on to others, any information or document provided by the principal as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
- iii) The Bidder/ contractor will not offer, directly or through intermediaries, any bribe, gift, consideration, reward, favour, any material or immaterial benefit or any other advantage, commission, fees, brokerage or inducement to any official of the Principal/Employer, connected directly or indirectly with the bidding process, or to any person, organization or third party related to the contract in exchange for any advantage in the bidding, evaluation, contracting and implementation of the contract.
- The Bidder/ contractor further undertakes that it has not given, offered or promised to give iv) directly or indirect any bribe, gift, consideration, reward, favour, any material or immaterial benefit or any other advantage, commission, fees, brokerage or inducement to any official of the Principal/Employer or otherwise in procuring the Contract or forbearing to do or having done any act in relation to the obtaining or execution of the contract or any other contract with the Principal for showing or forbearing to show favour or disfavour to any person in relation to the contract or any other contract with the Principal.
- v) The Bidder / contractor of foreign origin shall disclose the name and address of the Agents /representatives in India, if any. Similarly, the Bidder of Indian Nationality shall furnish the name and address of the foreign principals, if any.
- vi) The Bidder / Contractor further confirms and declares to the Principal/ Employer that the Bidder / Contractor is the original manufacturer/integrator/ authorized government sponsored export entity of the stores and has not engaged any individual or firm or company whether Indian or foreign to intercede, facilitate or in any way to recommend to the Principal/Employer or any of its functionaries, whether officially or unofficially to the award of the contract to the Bidder / Contractor, nor has any amount been paid, promised or intended to be paid to any such individual, firm or company in respect of any such intercession, facilitation or recommendation.
- vii) The Bidder/ contractor either while presenting the bid or during pre-contract negotiations or before signing the contract, shall disclose any payments he has made, is committed to or intends to make to officials of the Principal/Employer or their family members, agents, brokers or any other intermediaries in connection with the contract and the details of services agreed upon for such payments.

Bidder /contractor will not collude with other parties interested in the contract to impair the parency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract.

The Bidder / contractor will not accept any advantage in exchange for any corrupt practice, un nwans and illegal activities.

e Bidder / contractor shall not use improperly, for purposes of competition or personal gain, bass on to others, any information provided by the Principal/Employer as part of the business

relationship, regarding plans, technical proposals and business details, including information contained in any electronic data carrier. The Bidder also undertakes to exercise due and adequate care lest any such information is divulged.

- xi) The Bidder/ contractor commits to refrain from giving any complaint directly or through any other manner without supporting it with full and verifiable facts.
- xii) The Bidder/ contractor will not instigate any third persons to commit offences outlined above or be an accessory to such offences.
- xiii) If the Bidder / contractor or any employee of the Bidder/ contractor or any person acting on behalf of the Bidder, either directly or indirectly, is a relative of any of the officers of the Principal/Employer, or alternatively, if any relative of an officer of the Principal/Employer has financial interest / stake in the Bidder / contractor "s firm, the same shall be disclosed by the Bidder / contractor at the time of filing of tender. The term "relative" for this purpose would be as defined in Section 6 of the Companies Act 1956.
- xiv) The Bidder / contractor shall not lend to or borrow any money from or enter into any monetary dealings or transactions, directly or indirectly, with any employee of the Principal/Employer.

Previous Transgression

The Bidder / contractor declares that no previous transgression occurred in the last three years immediately before signing of this Integrity Pact, with any other company in any country in respect of any corrupt practices envisaged hereunder or with any Public Sector Enterprises in India or any Government Department in India that could justify Bidder / contractor "s exclusion from the tender process. If the Bidder / contractor makes incorrect statement on this subject, the Bidder / contractor can be disqualified from the tender process or the contract, if already awarded, can be terminated for such reason.

Sanction for Violations

Any breach of the aforesaid provisions by the Bidder / contractor or anyone employed by it or acting on its behalf (whether with or without the knowledge of the Bidder / contractor shall entitle the Principal / Employer to take all or any one of the following actions, wherever required: -

- To immediately call off the pre contract negotiations without assigning any reason or giving any compensation to the BIDDEER/CONTRACTOR, However, the proceedings with the other BIDDER/CONTRACTOR would continue.
- ii) The Earnest Money Deposit (in pre-contract stage) and / or Security Deposit / Performance Bond (after the contract is signed) shall stand forfeited either fully or partially, as decided by the PRINCIPAL/EMPLOYER and the PRINCIPAL/EMPLOYER shall not be required to assign any reason, therefore.
- iii) To immediately cancel the contract, if already signed, without giving any compensation to the BIDDER. /CONTRACTOR
- iv) If any outstanding payment is due to the bidders from the buyer in connection with any other contract, such outstanding payment could also be utilized to recover the aforesaid sum & interest.
- v) To encash the advance bank guarantee and performance bond / warranty bond, if furnished by the BIDDER/CONTRACTOR, in order to recover the payments, already made by the PRINCIPAL/EMPLOYER, along with interest.

To cancel all or any other Contracts with the BIDDER/CONTRACTOR. The BIDDER//CONTRACTOR shall be liable to pay compensation for any loss or damage to the PRINCIPAL/EMPLOYER resulting from such cancellation/ rescission and the PRINCIPAL/EMPLOYER shall be entitled to deduct the

amount so payable from the money(s) due to the BIDDER. /CONTRACTOR

- viii) To recover all sums paid in violation of this Pact by BIDDER/CONTRACTOR to any middleman or agent or broker with a view to securing the contract.
- In cases where irrecoverable Letters of Credit have been received in respect of any contract signed ix) by the PRINCIPAL/EMPLOYER with the BIDDER/CONTRACTOR, the same shall not be opened
- x) Forfeiture of Performance Bond in case of a decision by the PRINCIPAL/EMPLOYER to forfeit the same without assigning any reason for imposing sanction for violation of this pact.
- xi) The Bidder /CONTRACTOR accepts and undertakes to respect and uphold the Principal"s absolute right to resort to and impose such exclusion and further accepts and undertakes not to challenge or question such exclusion on any ground, including the lack of any hearing before the decision to resort to such exclusion is taken. This undertaking is given freely and after obtaining independent legal advice.
- xii) If the Bidder/CONTRACTOR can prove that he has restored/Recouped the damage caused by him and has installed a suitable corruption prevention system, in such a case, it will be discretion of the principal to revoke the exclusion prematurely.
- The PRINCIPAL/EMPLOYER will be entitled to take all or any of the actions mentioned at Para (i) to xiii) (xii) above of this Pact also on the Commission by the BIDDER/CONTRACTOR or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER/CONTRACTOR, of an offence as defined in Chapter IX of the Indian Penal code, 1860 or Prevention of corruption Act, 1988 or any other statute enacted for prevention of corruption
- xiv) The decision of the PRINCIPAL / EMPLOYER to the effect that a breach of the provisions of this Pact has been committed by the BIDDER/CONTRACTOR shall be final and conclusive on the BIDDER/CONTRACTOR. However, the BIDDER/CONTRACTOR can approach the Independent Monitor (s) appointed for the purposes of this Pact.

Fall Clause

The BIDDER/CONTRACTOR undertakes that it has not supplied / is not supplying identical product / systems or subsystems at a price lower than that offered in the present bid in respect of any other Ministry / Department of the Govt. of India or PSU and if it is found at any stage that similar product / systems or subsystems was supplied by the BIDDER/CONTRACTOR to the Principal at a lower price, then that very price, with due allowance for elapsed time, will be applicable to the present case and the difference in the cost would be refunded by the BIDDER /CONTRACTOR to the PRINCIPAL / EMPLOYER, if the contract has already been concluded.

Other Provisions

Changes and supplements as well as termination notices need to be made in writing. Side agreements have not been made.

If the Contractor is a partnership or a consortium, this agreement must be signed by all partners or consortium members.

Law and Place of Jurisdiction

This Pact is subject to Indian Law. The place of performance and jurisdiction is the seat of the PRINCIPAL / EMPLOYER.

Other Legal Actions

The actions stipulated in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the extant law in force relating to any civil or criminal proceedings.

Validity

The validity of this Integrity Pact shall be from date of its signing and extend upto 5 years or the comp execution of the contract to the satisfaction of both the PRINCIPAL and be Bidder / Contractor includes warranty period whichever is later. Equal treatment of all Bidders/CONTRACTOR / sub- contractors

- a) The Bidder/CONTRACTOR undertake to demand from all sub- contractors a commitment in conformity with this Integrity Pact, and to submit it to the principal before contract signing.
- b) The principal will enter into agreements with identical conditions as this one with all Bidders / Contractors and Sub-Contractors.
- The principal will disqualify from the tender process all Bidder / Contractors who do not sign this pact or violate its provisions.
