Engagement of Retired Staff as Consultant Purely on Contract Basis

G. B. 4. The Contractual appointment of the consultants shall be governed by the guidelines laid down by the Finance Department, Govt. of NCT Delhi vide OM No. 20/4/2015-AC/204-248 dated 04.12.2015 and other subsequent orders/guidelines as issued by the Competent Authority, GNCTD time to time.

7. The engagement of Consultant would be on full time basis and they would not be permitted to take up any other assignment during the period of Consultancy. The engagement of Consultants is of temporary nature and the engagement can be cancelled at any time by this Department without assigning any reason thereof.

8. The Consultant shall not be entitled to any allowance such as House Rent Allowance, reimbursement of Call Charges of Telephone/mobile, Transport facility, Residential Accommodation, Personal Staff etc. No Government Vehicle shall be provided to the Consultants.

9. No TA/DA will be paid for appearing in the interview. The appointment of retired staff as Consultant shall be subject to Vigilance Clearance, Medical Fitness and subsequent approval of the Competent Authorities under GNCTD.
