Sub: Notice inviting quotations from various intending bidders for providing PPE Kits on urgent basis

This institution is in urgent need of PPE Kits due to persisting Novel Corona Virus (COVID-19) Pandemic. The specifications and various terms and conditions of the item is detailed as under:-

Specifications is as under:-

- 90 GSM Coverall (Spun bond Non Woven Fabric +PE lamination) interwoven synthetic waterproof
- (Approval certificate including DRDO)
- Shoe cover made of same fabric as coverall (length upto knee)
- Safety goggles
- Biomedical waste bag
- 3ply face mask with nose pin
- Face shield:- reusable high quality
- Nitrile gloves- 1 pair
- Sterile Gloves- 1pair, N-95 Mask

In this regard, the procurement may be processed through the following process:-

Both the envelopes should be inserted in one big envelope and must be dropped into the box assigned for this purpose in Purchase Section on or before last date by 30.04.2020 12.00 PM. the samples should also be submitted in Surgical store of this hospital. Writing on it name of company on envelop/packing:-

Technical Stage: The technical bid/literature for the individual items submitted by the firms / companies shall be evaluated. The items /firms which qualify in this stage shall be judged at the Financial Bid Stage. The hospital authority reserves the right to cancel the technically approved items at any stage even after issue of supply order.

Financial E-Bids Stage: In Financial Bids the companies shall have to quote one price for the the PPE Kit (including all above item) inclusive of all taxes as applicable.

Note:- The intending participants are hereby advised to please submit your quotations as per details given below:-

There should be two different envelopes. The first envelope should be marked as technical bid wherein the technical specifications of the item should be detailed and literature should be inserted. The second sealed envelope should be marked as Financial Bid wherein the price of the item should be detailed. Both these envelopes should be inserted in one big envelope and this big envelope should be dropped into tender box kept in purchase section for this purpose well before 30.04.2020 at 12:00 noon. Please remember that the price bid should be dropped only in tender box and the rates should not be forwarded through e mail unless the tender shall not be considered and rejected straightaway without giving any reason.

Submit the sample in Surgical Store and quote only one your best item.

The quotation should be detailed with the rate of the item, GST, Minimum delivery period, complete contact address with mobile number. This issues with the prior approval of the Competent Authority.
