4. She/He will wear White Coat with Name Badge at his/her coat. He/She will not smoke in the institute campus while on duty or examining the patients.
5. The appointment may be terminated at any time by giving 01 month notice by the either side viz the appointee or the appointing authority without assigning any reason. The appointing authority reserve the right of terminating the services of the appointee forth with or before the stipulated period of notice by making payment to him/her of a some equivalent pay and allowances or the unexpired portion thereof.
6. Certificate of the course will only be issued after satisfactorily completion of the course and furnishing no dues certificate and other conditions required by the institute.
7. The appointment is provisional and is further subject to:
 - a) Production of Medical fitness from Medical Board, GIPMER, New Delhi.
 - b) Submission of DMC Certificate (with Eligible Qualification) at the time of joining.
 - c) The selected candidate must bring their NOC/relieving from their present employer.
 - d) She/He is further directed to bring all the certificate/testimonials (in originals) along with self attested copy of each, at the time of joining to the course.
 - e) She/He will not be entitled to any traveling allowance for joining in the institute.
